

CWP CHEMICAL PUMP UPTAKE SYSTEM

The chemical pump system, which uses Minncare® HD Disinfectant for RO system disinfecting, was occasionally experiencing random self-priming problems. This was primarily attributed to off-gassing causing an air lock in the pump head.

Starting with **CWP RO serial number 1299919**, a new chemical pump system has been implemented into production.

Auto purging vent line allows gasses to return to the Minncare bottle.

New ergonomic integrated fluid and electrical connectors (now available for retro-fit, see page 2).

A Chemical Panel Upgrade Kit, P/N W3T577999, is available for CWPs with the older pump and plastic chemical panel. This kit includes a new stainless steel chemical panel, auto purge pump, chemical pick-up tube and all required fittings, tubing, and components along with detailed instructions on how to install.



Refer to Tech Note 241 (W3T575587) for PM kit information. Additional spare part numbers are now available for future repairs. Certain legacy parts have been discontinued due to these design changes and their recommended replacements are listed on the last page of this document. There is no stock available of the legacy parts.

For users with the current SS chemical panel, new spare parts are available to replace the fluid and electrical connectors in case of failure. These parts include each panel mounted flange (W2T912225 for DISINFECT flange; W2T912226 for OPERATION flange), the hose connector from the pump to the flanges (W2T912224), and in case of failure of just the QD portion of the disinfect flange, a replacement cartridge is available (W3T577693).

Etatron PKX010889F was the chemical pump model used on the CWP from serial number 1299919, up to serial number 1369929. This pump used the silicone duck bill style check valves (W2T912127). Starting with serial number 1369930, the Etatron PKX010888T chemical pump was implemented in production (same form, fit, function). This new pump uses ceramic ball check valves. Refer to the parts list below for ordering details.

A redundant 2 PSI check valve was added to the CWP design in December 2020 to prevent backflow from the recirculation line through the chemical pump and/or the disinfection port. It replaces the JACO fitting (W2T914258) used to connect the chemical pump's discharge line to the CWP recirculation line (see image below). This JACO style check valve has been added to all CWP PM-B kits and can also be ordered separately (W3T578207).
